- 4. Minutes (March 17, 2016) The minutes were reviewed by board members in attendance. The motion for approval of the April 7, 2016 board meeting minutes was made by Liz Smith and second by Louis Reine. The minutes were approved without opposition.
- 5. Action Items Robin Heath, Chairperson, advised the Board members that they were to review the Workforce Innovation & Opportunity Act (WIOA) Region Regional/Local Plan for PY2016 PY2020.

Ms. Cynthia Douglas stated all of the Louisiana Local Workforce Development Boards were required to prepare a combined Local/Regional Plan.

Region 2 is comprised of the Parishes - East Ascension, East Baton Rouge, West Baton Rouge, Tangipahoa, East Feliciana, West Feliciana, Iberville, Livingston, Point Coupee, St. Helena and Washington. Draft plans are due by June 30, 2016.

An overview of the plan was submitted to the Board members. The plan is LWDB21's outline of the Workforce System for East Baton Rouge Parish as well as Region 2. LWDB 21 and 20 have worked to develop a plan that encompasses all of core partners and all support systems that are needed to provide the citizens of Region 2 with a complete service delivery system.

The motion to adopt the draft of the Workforce Innovation and Opportunity Act (WIOA) Region Regional/Local Plan (PY2016 – PY2020) for Region 2 was made by Louis Reine and second by Gerard Melancon. Abstaining from voting were Harlen Henegar and Liz Smith. The Workforce Innovation and Opportunity Act (WIOA) Region Regional/Local Plan (PY2016 – 2020) was approved without opposition.

Kelly LeDuff thanked all of the Board members that came to the Job Fair in May 2016. Over 1500 job seekers attended. Mr. LeDuff further stated that he hoped Board members could offer more assistance and support whenever there is a need.

Penny Collins expressed the benefits job seekers in having a chance to talk with the numerous employers. Some seekers had job offers while others were impacted with more knowledge of how to interview for a job.

Liz Smith thanked all of the Board members who helped with the Occupational Projections that were gathered by the Louisiana Workforce Commission. She stated that Sachin Chintawar, State of Louisiana LWC, also thanked the group's effort.

Gerard Melancon asked if there was anyone from Veteran's Affairs on the Board or a partner. Penny Collins stated Kenny Lynch, State of Louisiana VA rep, was a Board member. Kenny Lynch could help Gerard Melancon with contact of other Veteran Representatives.

James Windham announced the 3rd Annual Prison Job Fair and invited all of the board members to attend on Friday, July 8, 2016.
